These improvements were possible because our donors continued to give during a year of cutbacks and losses and we thank each and every one of you.

Our volunteer hours topped 32,000 in 2009 and to everyone's delight we were able to expand our therapy dog program, increase our scheduled van outings and continue our four night a week dinner program. Late in the year the H1N1 virus changed our daily routine and once again, we got amazing support helping families who had to move into isolation and in keeping our pantry full during flu season. We closed the year feeling very grateful to our friends, volunteers and supporters.

Because of you, the families here at the Seattle Ronald McDonald House had the support and services they needed so they could concentrate on their children.

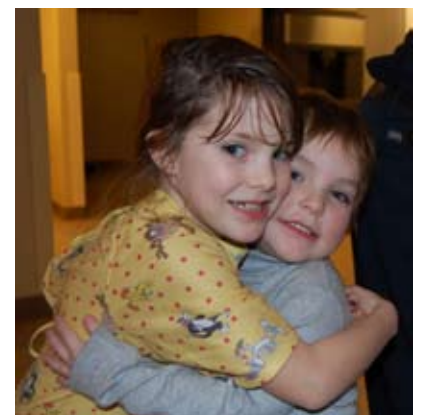

## Rheagen's Story

EVEN WEARY FROM the effects of a Wilms' tumor and now its relapse, Rheagen enjoys thinking about what matters to him. Bugs, in general, top the list. The Beta fish in his room at the Ronald McDonald House is currently a close second, and hummingbirds, ants and parrots all rate a mention.

Rheagen's close knit family, including his brothers, Colton, 4, and Trevin, 2, commonly spend their summers camping and hiking. But this past summer they stayed at the House, shuttling back and forth from Children's Hospital for the grueling chemotherapy and radiation sessions Rheagen must endure on his journey. The family arrived at the House in March, after a previous treatment plan failed. Now they expect to stay through October.

Usually in the midst of wiping dirty faces and playing referee to her band of boisterous boys, Rheagen's mother Brandie is quick to credit the House for making their situation tenable. "To have a home so close to the hospital is amazing. Even when it's dark, raining, or snowing, the shuttle takes us safely to the hospital." Raising three boys ages five and under always involves a certain degree of noise, mess and activity, and this can make being away from home even more difficult. Within the House, the basement playroom has proven to be a life saver more than once, providing enough space for the younger boys to zoom around on their bikes and spend some energy.

"Before I knew better, I was concerned about the communal living situation at the House," reflects Brandie. "Now I know being around other families going through the same circumstances is one of the best things. I would tell anyone just learning they would be coming here to open up to the other parents and talk. Everyone here can see you as a regular person. They know they don't have to treat you like you're made of glass, but they also understand all the same challenges."

Help from their landlord in Tacoma is allowing them to maintain the home they were just moving into when the first scary symptoms of Rheagen's illness started to appear. After the removal of one kidney, emergency heart surgery and lots of intensive treatments, Rheagen's current mission is to "teach cancer bugs a lesson." Of all the bugs he has caught over the years, this may be the only one he's wanted to get rid of. He'll always like spiders though.

# Our programs

## Kitchen Upgrades Help Volunteers Provide Family Meal Program

Kitchens are the heart of many homes, and nowhere is this truer than at the House. Originally built as a residential kitchen, the kitchen in House A needs to function on a daily basis for up to 48 families, complete with sinks, dishwashers, refrigerators, freezers, counter space, ovens, stoves and storage. In addition, the kitchen must support the numerous groups who volunteer over 200 nights of the year, making dinners and providing warm, nourishing meals for families.

Thanks to a grant from the Employees Community Fund of Boeing Puget Sound, these performance demands are now met through upgraded countertops, freezers and electrical voltage installed in 2009. Eleanor Garrison, Volunteer Services, is especially grateful for the high-voltage ovens. "We always want to make sure volunteer groups have a positive experience," she explains. "Before, volunteers couldn't plan on how long something would take to cook. Families were not aware there was an issue, but now the groups are reporting a much improved situation."

Families definitely notice and appreciate the installation of commercial freezers. Replacing smaller residential-type freezers where food became lost and outdated in the cramped, shared space, the new freezers offer dedicated space for each family, allowing them better access to their food and longer-term storage.

Another remarkable improvement to operational efficiency in 2009 came at the hands of 16 students from Edmonds Community College. They applied their training in Lean/Six Sigma, volunteering to streamline and develop standard operating procedures within the House pantry and maintenance room. By the end of their project, they reduced the amount of travel for food donations by 60%, decreased time looking for items by 50% and reduced labeling errors by 75%. "We are very grateful for the incredible difference these students made for our employees and volunteers. Having these efficiencies gives us that much more time to serve the families staying here," says Dianna Finnerty, Executive Director.

Everyone there is to be commended for making it a smooth running operation even throughout the challenges.*

# Our volunteers



## Work Groups Make Essential Contributions

Even throughout the economic downturn of 2009, the House was the grateful recipient of a record number of volunteer hours coming from work groups. These groups are invaluable to keeping the House running in top form as they weed, sweep sidewalks, vacuum, dust, organize and disinfect. "Families find a lot of comfort in coming home to a clean, organized environment, especially after long days at the hospital," says Judy Adams, Manager of Volunteer Services.

The groups, ranging from five to 50 people in size, come from companies and individuals from around the region. Often put together as part of a team building effort, the participants quickly learn and see first-hand how their contributions make a difference. "It was a wonderful experience for our team to volunteer at the Ronald McDonald House," reflects Larry Smolinski of Starbucks. "We knew it would be a great team building opportunity and a chance to give back to our community. We had a great sense of pride when we left because we really felt our efforts made a difference in the lives of people who could use some help."

One of the main benefits to volunteering as part of a work group is the chance to be around the families. "It is nice when families come in to use the facilities while we are there working. It really makes it real and we can see how we are helping," notes Eric Stewart of GE Healthcare.

The beautifully orchestrated flower beds just outside the House are the result of hundreds upon hundreds of hours donated by volunteers of the King County Master Gardener program and an obvious display of a work group's generosity and care for families at the House. Equally important are the hours spent by volunteers in deep-cleaning floors, silverware drawers and window sills, all in an effort to disinfect and keep invisible germs at bay.

"RMH has a beautiful facility that requires continuous care around the year," explains Rick Clothier of Clothier & Head, whose employees often volunteer in groups. "Our firm is honored to work with the team of Directors and Master Gardeners to help make the House a safe and hospitable place for families caring for their children."

## 2009 highlights

- Volunteer hours totaled 32,483 hours; the equivalent of 15.6 full time employees
- Over 27% of volunteer hours were allocated to providing the family meal program
- 99 groups volunteered to serve dinners 357 nights
- Front desk volunteers donated a total of 6,246 hours
- Activities provided for families by volunteers include yoga, crafts, movies, soccer clinics and dance lessons
- Other important services provided by volunteers include mending, gardening, driving vans, indoor and outdoor work groups for cleaning and upkeep
- 18 therapy dogs and their owners spent 1,135 hours interacting with families
- Total volunteer hours increased by 4% from 2008. Meals served in House C accounted for the largest increase with 27%

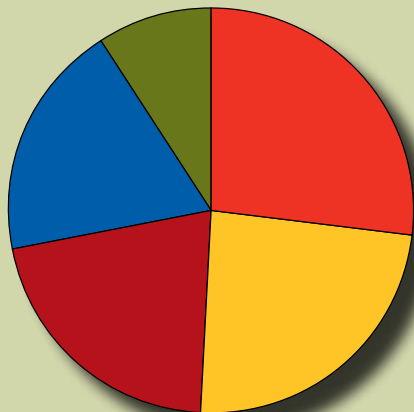

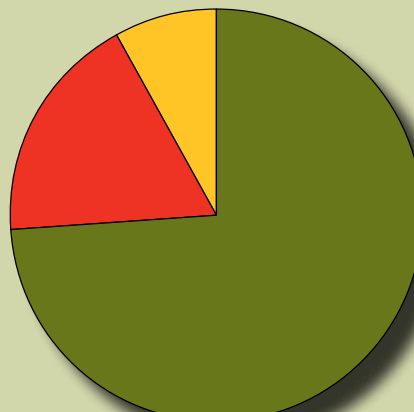
