ILL CHILDREN WHO MUST LEAVE THEIR OWN COMMUNITY TO HAVE THEIR CHILDREN  
TREATED AT SEATTLE CHILDREN'S HOSPITAL. IN 2017, 429 FAMILIES STAYED AT  
THE SEATTLE HOUSE.

THE SEATTLE RONALD MCDONALD HOUSE IS A COMFORTABLE AND NURTURING
