OPERATES THE SEATTLE RONALD MCDONALD HOUSE. WITH 80 ROOMS, THE SEATTLE  
HOUSE PROVIDES SUPPORTIVE, TEMPORARY LODGING TO FAMILIES OF SERIOUSLY  
ILL CHILDREN WHO MUST LEAVE THEIR OWN COMMUNITY TO HAVE THEIR CHILDREN  
TREATED AT SEATTLE CHILDREN'S HOSPITAL. IN 2019, 419 FAMILIES STAYED AT  
THE SEATTLE HOUSE.

THE SEATTLE RONALD MCDONALD HOUSE IS A COMFORTABLE AND NURTURING  
ENVIRONMENT. FAMILIES HAVE THEIR OWN INDIVIDUAL ROOMS AND BATHROOMS AND  
SHARE THE REST OF THE HOUSE - A FULLY EQUIPPED KITCHEN AND DINING AREA,  
A STOCKED PANTRY, COMPUTER LAB, LAUNDRY FACILITIES, A MOVIE THEATER AND  
PLAY AREAS. CHILDREN'S HOSPITAL IS JUST A BLOCK AWAY. FAMILIES WHO STAY

VERY DIFFICULT TIME IN THEIR LIVES.

BUILDING AND SERVES EXPECTANT MOTHERS WITH HIGH RISK PREGNANCIES AS  
WELL AS FAMILIES OF PEDIATRIC PATIENTS AT THE ALASKA NATIVE MEDICAL
